I agree not to seek contribution or indemnification from the City of Mesa, its officers, volunteers, officials, employees, agents and elected officials, if I am sued by any party in connection with my participation in the COM Yoga/Pilates Fitness Class.
I consent to the unrestricted use of my image and/or my name, in connection with the Yoga/Pilates Fitness Class by the City of Mesa or any person authorized by the City of Mesa, including, but not limited to, any photographs, audio or video recordings, interviews, videotapes, or motion pictures whether for television, radio or print media.
I agree to waive any and all claims that I may have against the City of Mesa, its officers, volunteers, officials, employees, agents and elected officials for any physical injury, death or property damage I experience arising out of participating in the Yoga/Pilates Fitness Class, including claims based in negligence.
